How the reBuy payment method works

↓ 01 Cashless payment of debts

Customers without sufficient funds to pay open invoices can trade in second-hand goods such as smartphones, games or Blu-Rays to settle debts fully or in part by visiting the Arvatooperated collection online service www.inkassoportal.de and selecting the respective payment solution.

↓ 02 reBuy - the innovative payment method integrated in the collection online service Inkassoportal.de

If customers select reBuy as their preferred payment solution on Inkassoportal.de, they are forwarded to the recommerce site, where they receive a fixed price offer for their used goods. If they wish to accept the offer, customers simply need to send the goods directly to reBuy, where submitted conditions are checked. If they comply with the seller's information and if the seller accepts reBuy's offer, the price of the goods is deducted from the seller's debt. Sales proceeds which exceed the amount of debt are credited to the seller's reBuy account and can be paid out on request.

↓ 03 Saving natural resources

Compared to purchasing new products, the decision to go second-hand saves both - money and resources. At reBuy, all goods are professionally refurbished to ensure they are in a suitable condition for second-hand sale.
